CONVENE

Roll Call, Establish Quorum, Moment of Reflection/Pledge of Allegiance President Schreiter called the regular meeting of the Board of Education to order at 5 p.m.

PUBLIC COMMENT

Dan Ireland, 102 S. Sallie Avenue, spoke about the increase in autism being due to glyphosate, quoting computer scientist Dr. Seneff.

Jim Hess, W3678 Sunny Road, Eden, talked about being fearful to speak up about issues because of being labeled racist or homophobic. He spoke against transgender speakers from a hearing in Madison, and cited an athletic group stating men are stronger than women. He apologized to women athletes for having to compete against trans women and to young people for having their bodies "mutilated."

Megan Stroup from Parkside spoke about highlights from the school. She shared that staff meets for data-driven instruction collaboration time. There is a lot of growth in shared reading, which increases knowledge and vocabulary. The units of study are going well, and she gave multiple examples of interesting points. The students are exhibiting good growth. New staff are feeling welcomed.

He shared that more students are being integrated into regular classrooms to increase engagement and achievement, and it is important in this process to maintain correct student to staff ratios.

Contracts for 2024-26

About half the administrators are up for renewal, and the others are up for renewal next year. MOTION BY Godfrey, seconded by Uselmann, that the Board of Education authorize that contracts be offered to the continuing administrative staff for 2024-2026. MOTION CARRIED, aves 7-0.

Consider Recommendation to Create a Director of English Language Learning and Bilingual Education

The creation of this position is necessary to provide leadership in the area of English Language Learning and Bilingual Education as District enrollment numbers of ELL students have continued to grow steadily (hundreds of students) over the last four years, and data suggests that this growth will continue. This position will be a stand-alone director rather than a coordinator to allow for more coordination, accountability, and evaluation. MOTION BY Henschel, seconded by Godfrey, that the Board of Education approve the administration's recommendation to create a Director of English Language Learning and Bilingual Education. MOTION CARRIED, ayes 7-0.

Chief of Schools Consider Approval of 2024-25 School Calendar

The calendar that was designed by committee, with staff input, and presented to the board in a prior workshop, is ready for formal approval. There will be six elementary planning days added at a later time. The board is pre-approving that as well here. MOTION BY Henschel, seconded by Godfrey, that the Board of Education approve the 2024-25 school calendar as presented. MOTION CARRIED, ayes 7-0.

BOARD/ADMINISTRATOR REPORTS Superintendent Announce Studer Education Survey/Board Training Dates

Dr. Fleig shared that employees are being surveyed currently. Students will be surveyed February 5-16, and parents February 13-29 which runs through parent teacher conferences, hoping for additional participation. On March 4th at 5pm the board will have training on the BoardDocs system.

Moder enjoyed sessions on finance, law, bullying, and for new board members. She also attended a Bold Women's Conference, which also collects funds to support young women's development of leadership. Henschel attended finance and budgeting, benefits, and legal sessions. Fleig shared that he was able to connect with other superintendents about shared challenges, opportunities, and legal issues.
