The purpose of the Budget Hearing is to present and review the 2023-24 Budget.

PRESENTATION OF THE 2023-24

PRELIMINARY BUDGET

Michael Gerlach, Chief of Finance and Operations, presented the 2023-24 Preliminary Budget. He reviewed the district goals and offered comparisons to other similar districts. District operation funds are a balanced budget. The exception is the general fund (10), which used funds for the stadium construction. The mill rate is projected to increase slightly to \$6.42, which is still close to the lowest in the area. Final budget action will be taken by the board in October.

PUBLIC COMMENT

Jim Hess, W3678 Sunny Rd., Eden, asked all to pray for the peace of Israel and the US because Hamas is already here. He cited an article where teachers were concerned about shortages and bus driver shortages. He spoke about transgender bill hearings in Madison last week, and claimed the state superintendent couldn't be trusted about risks to transgender students because she changed data benchmarks. He mentioned the Kettle Moraine school district court decision which disallowed the use of preferred pronouns without parental consent. He claimed the federal government cannot make rules for the states because of the Tenth Amendment.

Dr. Fleig shared that the National Exchange Bank and Barbara and Peter Stone Family Foundations are donating \$1 million dollars for new playgrounds at the nine elementary schools. The district will add in \$250,000. Accessibility will be a consideration as things move forward, with a type of wood chips that are deemed handicap accessible rather than rubber surface.

Literacy Task Force

Literacy has not been growing at the same rate as mathematics and there will be a task force of district teachers from elementary and middle levels, representatives from the principal core and some administrators. This builds on the reading bill passed at the state level.

(This is not actually happening.) He also reiterated that the Recreation Department staff should be returned to the building near Woodworth. Dan Ireland, 102 S. Sallie Ave., shared a DeVos book story about protesters during a voucher school visit, that protesters were there for unions and blue politicians, not the children.

Charlotte Trotter, 77 E. 11th St., invited the public to the boys' volleyball game at 7pm tomorrow night. The team is having a winning season. She also spoke about black students using the Aquatic Center and needing appropriate swim caps for their hair.
