CONVENE

Roll Call, Establish Quorum, Moment of Reflection/Pledge of Allegiance

President Schreiter called the regular meeting of the Board of Education to order at 5pm.

A Moment of Reflection preceded the Pledge of Allegiance which was led by the Board.

ANNOUNCEMENTS/ COMMUNICATIONS

President Schreiter made the following announcements:

- November 13-17, 2023 is Hunger and Homelessness Awareness Week Hunger and Homelessness Awareness Week is designed to educate the public, draw attention to the problem of poverty, and build up the base of volunteers and supporters for local antipoverty agencies.

PUBLIC COMMENT

Sue Heitzman, 209 Hass Circle, spoke about her retirement and issues with her email account. She filed an open records request about messages that may have been sent to the account during a period where it wasn't yet producing a bounce back message. She wants the fee for retrieving the records waived.

Dannie Mor, 247 E Bank St., again referenced his Black History for Moral Progress Wordpress account pages 44 and 45. He referenced the WDPI pamphlet about goals for students' preparation for global citizenship, and a number of events in the past couple dozen years. He expressed concern about antisemitism on college campuses. He asked for a comparative religion class from a mystical point of view, an extension of his mental yoga proposal, and spoke about Quran interpretation.

MOTION CARRIED, ayes 6-0 (Hoerth absent and not voting).

Consider Limited Term Administrator Contract for Interim Athletic Director

James Smasal is a retired educator from the Kewaskum district.

MOTION BY Henschel, seconded by Godfrey, that the Board of Education approve the employment of James Smasal as the Interim Athletic Director on a limited term contract for 180 days beginning October 23, 2023 and ending on June 30, 2024 at a salary of \$83,132.31. MOTION CARRIED, ayes 6-0 (Hoerth absent and not voting).

Consider Limited Term Administrator Contract for Interim Director of Facility Services and Safety

Randal Johnston is retired from Elmbrook district.

MOTION BY Godfrey, seconded by Henschel, that the Board of Education approve the employment of Randal Johnston as the Interim Director of Facility Services and Safety on a limited term contract for 144 days beginning December 1, 2023 and ending on June 30, 2024 at a salary of \$82,500.

Consider Approval of Base Wage Settlement with the Educational Support Professionals Association (ESPA) for the 2023-24 Bargaining Year Reflecting a 4.7% Consumer Price Index Increase

MOTION BY Schreiter, seconded by Pennau, that the Board of Education approve the following resolution:

WHEREAS: Representatives of the Fond du Lac School District School Board (hereinafter, "Board") and the Education Support Professionals Association (hereafter, "Association") have been engaged in good faith negotiations for a successor to the 2022-2023 Collective Bargaining Agreement between the parties; and

WHEREAS: The parties have met on May 22, 2023; August 9, 2023; and September 20, 2023 for the purpose of negotiations regarding a 2023-2024 base wage increase; and **WHEREAS**: The Board base wage proposal to the Association is for a 4.7% increase for the 2023-2024 school year; and

WHEREAS: The Board 4.7% base wage increase proposal matches the 2023-2024 settlement between the Board and the Fond du Lac Education Association; and **WHEREAS**: The Association has not accepted the Board's base wage proposal for the 2023-2024 school year; and

WHEREAS: The District believes that it is both appropriate and necessary to conclude these negotiations and provide a 2023-2024 base wage increase to the employees who are members of the bargaining unit represented by the Association;

THEREFORE, be it here resolved by the School Board of the Fond du Lac School District, that:

- (1) The Board declares that the parties are at impasse in negotiations over the 2023-2024 Collective Bargaining Agreement between the Board and the Association:
- (2) The Board's 2023-2024 base wage proposal to the Association is to be implemented as soon as practicable; and
- (3) This base wage proposal shall be incorporated in the 2023-2024 Collective Bargaining Agreement between the parties.

PUBLIC COMMENT

Sue Heitzman, 209 Hass Circle, noted that several messages to former staff members did not bounce back; labeled this as lacking ethics and competence.

Amber Kilawee, 235 E. 2nd St., noticed that flu vaccine clinics were not offered this year and was concerned about the added burden on some families working to get kids vaccinated.

Charlotte Trotter, 77 E. 11th St., talked about children not being singled out for achievement recognition and complemented "Gertrude McFuzz" from Seussical. She mentioned that students with disabilities and English language learners are outperforming black students. The school social media posted a state football sendoff, and she noted other activities don't get the same treatment.

Jim Hess, W3678 Sunny Rd., thanked Dr. Fleig and the board for giving students a target to hit. He mentioned DEI, the Great Society and data about out of wedlock black births. He said the behavior of poor blacks caused their poverty and called the black board member his brother, citing the Bible. He talked about a conference where teachers were taught racist ideas and quoted a mass shooter's manifesto. He worried that young white men were not attending university.
