PUBLIC COMMENT

Dannie Mor, 247 E. Bank St., "resubmitted" two proposals he made in 2019 by mentioning again his WordPress site. The proposals are about race and morality, and mental health. He was angry that his books and DVDs were not made requirements in the schools, and that he had been told teachers had expertise. He stated that he also had expertise, especially about mental health and Eastern practices, and referred to his knowledge of voga.

Cheryl Mohr, 530 Luco Rd., a parent, spoke about the great experience her children have had in the FDL school district, from "both ends of the spectrum," and successful transitions to adult careers. She asked that the board support all children and continue to offer diverse opportunities and named educators who were influential. She also stated that naysayers should get involved.

Jim Hess, W3678 Sunny Rd., Eden, talked about the district mental health report and suicide among teens nationwide. He stated that God was kicked out of school and evolution filled the vacuum. In the 80s, "death education" was introduced in schools. He said that children are no longer taught what is right and wrong, and referenced transgenderism and abortion.

University of Virginia (UVA) Partnership with Leaders in Education (PLE) Schools Present 90-Day Plans -Parkside, Pier, and FHS
