

Fond du Lac High School Parking Lot Rules

The parking lot regulations will be enforced by Section 346.55 of Wisconsin State Statute.

- A. Cars must be properly registered.
- B. Parking tag/pass must be hung on the rear view mirror. Purchase in Business Office \$25.00 for the school year. A new parking tag/pass is required each school year.**
- C. Cars must be parked legally – within the parallel lines.

Rules for Student Parking

1. Students must have a valid and current driver's license to apply for a parking permit.
2. Lots A, B, and C are available to all students. **Lot A has a designated "Visitor" area on the west side of the lot. No students are permitted to park in this area. Usage of this "Visitor" area will be strictly enforced. NO EXCEPTIONS.**
 - **Any parking citations believed to be received in error should be brought to the School SRO within 3 days.**
3. Parking passes are valid in designated parking stalls only, and only for the school year stated on the pass.
4. Handicapped parking stalls are only to be used for cars that have a legal handicap placard or license plate.
5. No illegal narcotics, alcohol, or weapons are allowed in your vehicle.
6. Smoking/ vaping is not permitted anywhere on school property, including in any vehicle.
7. Vehicles should be locked at all times. Do not keep items of value visible in your vehicle.
8. Vehicles are not to be used as lounging areas.
9. No littering
10. Students must obey all school rules in the parking lot.
11. Careless/ reckless driving will not be permitted.
 - a. Speed limit on school grounds is 15 mph at all times.
 - b. Please stay on hard surfaces. Any "off-roading" may result in a citation and/or loss of parking pass privileges, as well as potential restitution for any damage done.
 - c. "Burn-outs," racing, "wheelies," "car-surfing" or any other dangerous behaviors will not be tolerated, and may result in a citation and/or loss of parking pass privileges.

If any student is involved in an accident on Fond du Lac High School grounds, they are to immediately report the accident to the main office (920-929-2740 Ext. 6) during school hours, or the FdL Police Dept. (920-906-5555 or 911 if emergency), if the accident occurs before or after school hours.

I understand that the parking lot is public property that is under the control of the Fond du Lac School District. I will prominently display the parking permit on the vehicle designated for access. I agree that the authorized vehicle will not be used to transport or store any contraband of any kind, and will not use the lot in any way that will violate the school district code of conduct or criminal law.

I hereby understand and give the administration of the Fond du Lac High School (or their designee) my consent to search the authorized vehicle when it is parked on school property.

As the responsible party for the vehicle, my signature on the parking permit application states that I hereby agree to the above-stated terms and responsibilities in connection with obtaining authorization to use the school parking facilities.
